ORDER

WHEREAS the institution namely Poddar Management Training Institute zone-75, sector-7, opp. Water tank, shipra, Jaipur was granted recognition vide NRC, NCTE order No. F. NRC/NCTE/F-7/RJ-1071/2007/24141-2147 dated 28th August, 2007 for conducting B.Ed. course of one year duration with an annual intake of 100 (One Hundred only) students.

AND WHEREAS a letter received from the institution in NRC office on 31.12.2012 requesting shifting of B.Ed. course from its present building. The case was considered by NRC in its 210th meeting held from 28th to 29th January, 2013 and it was decided that the inspection of the institution was conducted on 19.03.2013.

AND WHEREAS the VTR was considered by the NRC in its 214th meeting held from 24th to 25th April, 2013 and it was decided to issue Show Cause Notice. Accordingly, a Show Cause Notice was issued to the institution on 21.05.2013 on the following grounds:

- The land is not free from all encumbrance as required under clause 8 (7) (1) of NCTE Regulations. The land papers are in lock in relation to get loan as per VT report.

AND WHEREAS the NRC in its 247th meeting held from 23rd to 29th December, 2015 considered the file of the Institution and the inspection and other related documents, NCTE Act, 1993, Regulations and the Committee decided that the Poddar Management Training Institute premises permitted from zone-75, sector-7, opp. Water tank, shipra, Jaipur, in Plot no. 806, Fatehpurva, Vaatika, Tehsil-Jaipur. An order restoring recognition of the institution for two basic courses for B.Ed. course as per the provisions of the NCTE Regulations, 2014 be issued.

NOW THEREFORE, the institution is allowed to shift its premises to "Poddar Management Training Institute, Plot No. 806, Fatehpurva, Vaatika, Village/Town-Sanganer, Tehsil-Chaksu, District-Jaipur, Rajasthan" for the B.Ed. course with an annual intake of 100 (one hundred only) for two basic units of 50 students each under clause 8 (7) (1) of NCTE Regulations 2014 subject to fulfilment of the conditions mentioned herein before 29.03.2016.

The institution fulfilling following conditions namely:

- The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds as per Regulations, 2014 and inform Regional Committees with required documents by May 30th, 2016.
- The application-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified format available on the website to the Regional Committee in proof of having provided additional facilities before May 30th, 2016. Building completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting Team at the time of inspection.
- The institution shall identify/selected the faculty/staff and obtained the approval from the affiliating body for the same by 29th February, 2016 and same be conveyed to the Northern Regional Committee by that date.
- The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these condition after May 30th, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to the Regional Committee along with the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating institution Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.

Therefore, in the light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order for the institution **Dr. K. Ramakant Ramawati Devi Arya Mahila P.G. College, Gorakhpur-273001, State - Uttar Pradesh** for conducting the programme of two years duration with an annual intake of 100 for two basic units of 50 students each from the academic year 2016-17 onwards, subject to fulfillment of the conditions mentioned herein before 29.02.2016.

Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies or U.G.C. affiliating University/ Body, State Government etc. as applicable. The affiliating body (University/State Govt.) shall be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provision of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.

The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

The institution shall maintain & update its website as per provisions of NCTE Regulations and always display following as mandatory disclosure.

- (i) Sanctioned programmes along with annual intake in the institution.
- (ii) Name of the faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- (iii) Name of faculty members who left or joined during the last quarter.
- (iv) Names of students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.
- (v) Fee charged from students.
- (vi) Available infrastructural facilities.
- (vii) Facilities added during the last quarter.
- (viii) Number of books in the library, journals subscribed to and additions, if any, in the last quarter.
- (ix) The affidavit with enclosure submitted along with application.
- (x) The institution shall be free to post additional relevant information, if it so desires.
- (xi) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution contravenes any the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.
